BUILDING CONSTRUCTION PLAN REVIEW AND PERMIT FEES

All fee calculations are based on the total project valuation, as reported by the contractor

FRFR issues building construction permits for any new building construction or any proposed modifications to an existing building, such as a remodel, tenant finish, or change of use. FRFR permits are not required to construct, remodel or renovate one- or two-family homes, or townhomes.

FRFR building construction permits are in addition to any municipal permits for projects within the Town of Milliken, Town of Johnstown, Weld or Larimer County within the FRFR response area.

PLAN REVIEW: Fees will be assessed at a rate of 0.002 times the project value*, minimum fee of \$160.00. Plan review fees are due at the time of project submittal

PERMIT: Fees will be assessed as 50% of the plan review fees. Permit fees are due prior to the release of the building construction permit.

IMPACT FEES are required for all new construction, including one- and two-family homes and townhomes. Refer to Page 3 of this document for a description of the required impact fees.

FIRE PROTECTION SYSTEM PLAN REVIEW AND PERMIT FEES All fee calculations are based on the total project valuation, as reported by the contractor

FRFR issues permits for installation of any new fire alarm or fire sprinkler system, including fire pumps, kitchen hood suppression systems, bi-directional amplification systems, underground fire lines, etc.

UNDERGROUND FIRE LINES are required by Colorado law (8 CCR 1507-11) to be approved and inspected by a certified Fire Inspector. Plan review requirements include all details of the proposed installation, from the point of connection with the municipal water supply to the termination inside the building.

FRFR also issues permits for any modification to an existing system.

These permits are in addition to any permits required by the municipality. Permits shall only be issued after review and approval of submitted plans.

RESIDENTIAL FIRE SPRINKLER SYSTEMS will be assessed a flat rate of \$400.00 per project.

PLAN REVIEW: Fees will be assessed at a rate of 0.006 times the project value*, minimum fee of \$160.00. Plan review fees are due at the time of project submittal

PERMIT: Fees will be assessed as 50% of the plan review fees. Permit fees are due prior to the release of the building construction permit.

Project Value means the construction cost of the project including materials and labor, for which the permit is being issued. Construction cost is equal to the cost of the project as demonstrated by detailed estimates provided by the business entity. Building construction valuation shall include electrical, plumbing, and mechanical systems.

Notice of Charge for Credit Card Payments: Front Range Fire Rescue accepts credit card payments through a contract under the authority of Colorado's Statewide Internet Portal Authority. The price to make a credit card payment to FRFR will be the transaction amount plus \$0.75 multiplied by 2.25%.

Fee Collection Information

The fees defined in this document are authorized for collection within all areas served by Front Range Fire Rescue, in accordance with Section 32-1-1002(1)(e), § CRS. All fees are established to account for FRFR staff hours dedicated to planning and engineering meetings, review of submitted drawings, plans and plats, as well as correspondence and consultation related to the project. Each assessed fee also includes one (1) site inspection.

Payment of the full plan review fee amount is required at the time of application. Payment of the full permit fee amount is required prior to FRFR releasing any applicable permit. No work may be performed without a current and valid permit.

Work completed without a permit will be assessed a penalty in the amount of 50% of the permit fees for the project.

All fees are non-refundable.

Plan Review and Permit Fees for New Oil and Gas Development

FRFR reviews and issues permits for all proposed new oil and gas development and/or exploration projects to ensure appropriate access and water supply are provided, and that appropriate safety measures are in place concerning management of hazardous materials.

The plan review fee shall be paid at the time of project submittal. An additional fee shall not be assessed for the Construction Permit or the initial Annual Operational Permit for the facility. A separate fee shall not be assessed for re-submittal of plans to make corrections based on FRFR review comments.

Initial plan review and permit fees for proposed new oil and gas development projects shall be billed at a rate of \$165.00 per well head, \$225.00 per oil tank, and \$75.00 per all other tanks.

Annual Operational Permits for existing oil and gas developments and/or facilities shall be billed at a rate of \$50.00 per well head.

New oil and gas developments and/or facilities within municipal boundaries will also be assessed an Impact Fee, as discussed below, based on the square foot measurement of the finished operating facility after all reclamation efforts have been completed.

Subdivision/Development Review

FRFR reviews all proposed new subdivisions and/or developments to ensure appropriate access and water supply are provided, and other pertinent fire safety issues are properly addressed. Examples may include land divisions; annexations; rezoning; use by special review; residential, commercial or mixed-use subdivisions; plats, PUDs, etc. The plan review fee shall be paid at the time of project submittal. A separate fee shall not be assessed for re-submittal of plans to make corrections based on FRFR review comments.

Additional Service or Re-Inspection (\$80.00/hour)

Other services not addressed in the specific plan review sections may be assessed a plan review fee of \$80.00 per hour to account for staff time. Every permit issued includes one (1) inspection for each phase of the project. If additional inspections are required beyond the one (1) allowed, a re-inspection fee of \$80.00 per hour, or fraction thereof, may be billed. Any required re-inspection fees must be paid prior to the inspection being scheduled.

After-Hours Inspections

Inspections of any type that are requested to be performed outside of normal business hours of 8:00am - 5:00pm, Monday through Friday, will be assessed a fee of \$80.00 per hour, with a minimum of two (2) hours billed.

Impact Fees for New Development

In the 2016 legislative session, the Colorado General Assembly passed House Bill 16-1088 that created Colorado Revised Statute 29-20-104.5, which authorizes fire protection districts to impose an impact fee on new development if the impact fee is authorized by local government.

The towns of Milliken and Johnstown have enacted municipal code to allow FRFR to collect impact fees for all new construction projects. FRFR has also been authorized to collect impact fees for all new construction projects within unincorporated Larimer County. Impact fees are assessed and payable at the time a town or county building permit is issued.

Please refer to the FRFR Impact Fee Form for specific information on current impact fees assessed.

Impact fee waivers or requests for in-kind contributions in lieu of impact fees may be submitted in writing to the Fire Chief, and they will be evaluated on a case-by-case basis.

Fees for One-Time Operational Special Events and/or Hazards Permits

Front Range Fire Rescue issues annual permits for many operations/processes that present special hazards to the public. Prior to issuance of an operational permit for any hazardous operation and/or process, the owner or operator shall submit a complete application package that provides all necessary details of the proposed operation and/or process.

Applicable fees shall be collected at the time of application and shall include the initial annual operational permit, if approved. These fees will be assessed in addition to any new construction/development review fees charged by FRFR for a new building or fire protection system.

Fees for On-Going Hazardous Materials Processes and/or Operations

In addition to any FRFR fees for building construction and/or fire protection system permits, any application for proposed new hazardous materials processes and/or operations will be assessed a plan review fee based on the type(s) of hazards at the "Additional Services" hourly rate of \$80.00 per hour.

After FRFR plan review has been completed and any discrepancies corrected, an annual operational permit will be issued. There will be no additional charge for the initial annual operational permit; however, renewal of each permit will be contingent upon an FRFR fire inspection and payment of any applicable annual permit fees based on the tables below. Refer to IFC Tables 105.6.8, 105.6.10 and 105.6.20 below for specific information on quantities that require a permit.

As such, all marijuana establishments or businesses, and all establishes or businesses performing hazardous processes with marijuana and/or hemp, shall be required to obtain all applicable construction and annual operational permits from FRFR, as well as applicable licensure from the State and municipality within which the business is located. Permits shall only be issued upon complete plan review and inspection.

Administration of FRFR Fee Collections

- 1. The Deputy Chief of Life Safety is authorized to make interpretations, clarifications, and/or changes to fee descriptions.
- 2. The Deputy Chief of Life Safety is authorized to collect plan review fees, inspection fees, permit fees, and all other fees as set forth in this fee schedule.
- 3. The Fire Chief is authorized to review applications for fee waiver and determine if a waiver shall be granted.
- 4. All fees must be paid in full prior to issuance of a permit or approval of any construction documents.
- 5. Returned checks shall be assessed a processing fee of \$35.00 per occurrence.
- 6. Fees that are not paid by the required payment date may be assessed an additional charge of 10% of the total amount billed for each 30 days the fees are not paid.
